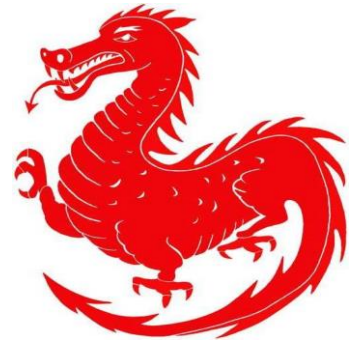

- b. Resolution for the Advancement of Taxes Collected (O.R.C. 321.34)

Be it resolved by the Niles City Board of Education that the Auditor and the Treasurer of Trumbull County, Ohio, be requested, respectively, to draw and pay to the Treasurer of the Niles City Board of Education for the General Fund, Emergency Operating Levy, Bond Retirement, and Maintenance Fund, in accordance with Section 321.34 of the Ohio Revised Code, the maximum money derived from taxes, settlements, or other sources, payable by law to the County Treasurer, and lawfully applicable to the purpose of the current calendar year, 2024.
